## COURSES OFFERED

We at People's Education Society's Law College have introduced Five years Integrated B.L.S. / LL.B. degree course in Law. The Three years LL.B. degree course will be introduced in near future. Admissions to Five years degree course in law can be taken after passing H.S.C. Board examinations from any discipline.

### **Eligibility for Admission**

Students who have passed H.S.C. or equivalent examinations from any stream, with 45% or above marks are eligible. However, the above percentage of marks shall be relaxed by 5% for candidates belonging to the Reserved Category. IB students have to submit the predicted grade and certificate of conversion of grades into percentage if their result is not declared at the time of submitting the form. Enrollment at Bar shall be subject to approval and rules of the Bar Council of India.

### **Prohibition to register for two regular courses of study**

No student shall be allowed to simultaneously register for a law degree program with any other graduate or post-graduate or certificate course run by the same or any other university or an institute for academic or professional learning excepting in the integrated degree program of the same institution.

Provided that any short period part time certificate course on language, computer science or computer application of an institute or any course run by a Centre for Distance Learning of a University however, shall be accepted. (Rule 6, Rules of Legal Education 2008, Bar Council of India.)





## ADMISSION FORM AND DOCUMENTS REQUIRED:

Application form for Five years Integrated B.L.S. / LL.B. degree course is enclosed in the prospectus. Forms duly filled in must be submitted to the College office. Admissions are based on merit. Students are required to take the admission in person by submitting the following certificates with the application form:-

- 1) Original statement of marks of the qualifying examinations along with two (2) attested photocopies.
- 2) Passing certificates of qualifying examinations with two (2) attested photocopies.
- 3) Two attested photocopies of School Leaving Certificate.
- 4) Four (4) recent passport size photographs.
- 5) If the student is from other than Maharashtra Board, he/she should submit the following additional documents:-
  - (a) Original Migration Certificate from the Board which he passed the examination and an attested photocopy.
  - (b) Original Provisional Eligibility Certificate from the University of Mumbai and a Photocopy.
- 6) In case of a student from a college affiliated to the University of Mumbai, No Objection Certificate (NOC) from that college.
- 7) Foreign students seeking admission should produce their passport & student's visa at the time of admission. Students on tourist visa will not be admitted to the college.
- 8) Married female students should produce attested true photocopy of marriage Certificate or in case of change of name, they should produce an affidavit and an attested true photocopy of gazette publication.
- 9) Undertaking to attend a minimum of 75% of the total number of lectures held during each semester as per University Regulations.
- 10) The Principal should be informed in writing about any change in the information submitted by the student in the admission form.
- 11) If subsequently it is found out that any statement of the applicant is incorrect or false, his/her admission is liable to be cancelled without refund of fees.
- 12) Students from Universities other than the University of Mumbai will be admitted provided that the examinations of the other Universities are considered equivalent and are subject to the provisions of eligibility conditions of the University of Mumbai.





## FEES

The fees for the First Year is Rs. 13830/- [which includes Rs.220/- towards enrolment fees, Rs.100/- towards Uniform Identity Number (Item 4, Schedule IV Rules of Legal Education 2008, Bar Council of India), Rs.920/- towards examination fees for the first and second Semester, Rs.250/- towards Caution Money (refundable) and Rs. 300/- Library deposit (refundable) or as per the University of Mumbai's directive and subject to the approval of the concerned authorities. Full fees must be paid along with the required deposit amounts at the time of admission. No student will be permitted ordinarily, to appear for any of the University/College Examinations if he/ she has not paid the College/Examination fees for the year.

Fees are payable by Demand Draft / Pay Order drawn in favor of "**PEOPLE'S EDUCATION SOCIETY'S LAW COLLEGE**". Fees and other dues shall be payable as prescribed from time to time by the competent authorities.

### **Refund of Fees:**

#### **Fee Deduction on Cancellation of Admission**

Students are advised to preserve their fee receipt carefully. Refunds of deposits/admission cancellation fees will be made only by cheque on submission of the original fee receipt. A duplicate fee receipt may be issued on payment of Rs. 50/- with the special permission of the Principal.

Caution money and library deposit amount will be refunded to the students from 1<sup>st</sup> August to 30<sup>th</sup> September on completion of the 5 year course.

### **Attendance:**

Students must attend lectures, practicals, tutorials, etc. as per the Time-Table. They must not abstain themselves from classes, practical's, tutorials, examinations etc. without written permission of the Principal. Students whose attendance, progress in various tests and examinations is not satisfactory and who do not attend the required number of tutorials and / or practical's are likely to lose their terms. Students who do not submit compulsory project work in any subject are likely to lose their term. Prolonged absence even on grounds of ill health may also lead to loss of terms. Defaulters will not be allowed to appear for the University Examinations.

### **Examination:**

#### **Standard for passing the B.L.S./LL.B Examination**

R. 4437:- To pass the examination the candidates must obtain 45% marks in each theory paper/s and Practical's separately. Those candidates who obtain less than 60% marks at the same sitting will be placed in Second Class. Those of the successful candidates who obtain 60% marks and more than 60% marks in all papers at one and the same sitting will be placed in the First Class.

A candidate who obtains 45% marks in Theory papers and Practical's may, at his option be exempted from appearing in the papers and practical's as the case may be.



If a candidate is allowed to join the next higher class as provided in the Ordinances relating to the different examinations, he will not be permitted to appear for the high examinations unless (i) he has previously passed in the remaining subjects of the lower examination, or (ii) he appears in that subjects simultaneously with his appearance at the higher examinations. In the latter case, however, he will, in no circumstances be considered to have passed in the higher examination, or any part of it, unless he passes in the aforesaid subjects (with the percentage, if any, required for the total) at the same time or within two years of his obtaining the marks necessary to pass in the higher examination or any part of it in which separate passing or exemption is permitted by the Regulation.

When a candidate owing to his failure to pass in the remaining subjects of the lower examination within two years is not considered to have passed the higher examination or any part of it, he will forfeit all benefits occurring from the marks obtained by him in the higher examination, but the terms kept by him for such higher examination will be available to him for any further appearance at the examination.

No candidate will be admitted to, and allowed to appear at, the year end semester examinations unless he/she has successfully passed the Examination in the Practical Training papers for the respective semester to be conducted by the respective colleges affiliated to the University of Mumbai, on behalf of the University.

**Term grant and examination:**

To keep a term at a college or recognized institution, an undergraduate must complete to the satisfaction of the Principal or the Head of the institution, the course of study at the college or institution prescribed for such terms for the class to which such undergraduate then belongs.

Although illness or other serious circumstances may be considered valid for the absence at lectures, tests, tutorials; the circumstances cannot condone a student for poor performance or absence and exempt them from appearing for examinations. Accordingly, student with poor records of academic performance will not be granted terms.

Students who have not been granted term will not be permitted to appear at the First Term/ Second Term/ Annual Examination conducted by the College or by the University.

There will be an examination at the end of each semester. The examinations at the end of the semester I, II, III and IV will be held by the college on behalf of the University of Mumbai according to the University of Mumbai rules.

The University of Mumbai will hold the examinations at the end of Semester V, VI, VII, VIII, IX and X.





### **Library:**

The College library will remain open from 8.00 am to 5.00 pm on all working days from Monday to Saturday.

- 1) Text-book section stocks recent editions of Text books, Bare Acts, University Examinations Question Papers etc.
- 2) Students can borrow text books for home reading from lending section. The rules & regulations of the library will be provided to the students separately.
- 3) Ex-students of the college will be permitted to use the library reading hall with prior permission from the Principal on payment of a library fee of Rs. 300/-.

### **Identity Card:**

Every Student must wear the Identity Card as long as he/she is on the College Campus. It must be produced by the student whenever demanded by a member of the teaching or non-teaching staff of the College. She/he must take proper care to avoid its misuse by other students and outsiders. In case the Identity Card is lost, the matter should be immediately reported to the Principal and an application should be made for a duplicate Identity Card which will be issued on payment of charges.

### **Discipline:**

1. No society or Association shall be formed in the College and no person should be invited in the College campus without the specific permission of the Principal. The Principal has a right to refuse such permission.
2. All meetings, cultural programs, debates, elocutions, moot-court etc. organized on the College Premises must be held in presence of teaching staff members and with the prior permission of the Principal. The subjects of debates/elocutions/ moot-courts must have the prior approval of the Principal.
3. Students involved in malpractices at the College/University Examinations will not be admitted to the College.
4. Students shall not do anything inside or outside the College that will interfere with the discipline of the College or tarnish the image of the College or of the other students.
5. Smoking is strictly prohibited on the College Premises.
6. If, for any reason, the continuance of the student in the College is found detrimental to the best interest of the College, the Principal may either ask the student to leave the College without assigning any reasons or refuse to admit the student for the next academic year; and such decision will be final and binding on the student.
7. Acts of Misbehavior, Misconduct, Indiscipline or Violation of the Rules of Discipline mentioned above are liable for one or more punishments as stated below:
  - a. Warning to the student.





- b. Warning to the student as well as a letter to the parents.
- c. Imposition of a fine.
- d. Denial of gymkhana, library, N. S. S., student-aid or any other facility for a specified period or for the whole Term/Year.
- e. Cancellation of Terms.
- f. Refusal of admission in the next term or academic year.
- g. Cancellation of Admission.
- h. Expulsion from the College for a specified period.
- i. Rustication.

#### **Internship:**

(a) Each registered student shall have completed minimum of 12 weeks internship for Three Year Course stream and 20 weeks in case of Five Year Course stream during the entire period of legal studies under NGO, Trial and Appellate Advocates, Judiciary, Legal Regulatory authorities, Legislatures and Parliament, Other Legal Functionaries, Market Institutions, Law Firms, Companies, Local Self Government and other such bodies as the University shall stipulate, where law is practiced either in action or in dispute resolution or in management.

Provided that internship in any year cannot be for a continuous period of more than Four Weeks and all students shall at least gone through once in the entire academic period with Trial and Appellate Advocates.

(b) Each student shall keep Internship diary in such form as may be stipulated by the University concerned and the same shall be evaluated by the Guide in Internship and also a Core Faculty member of the staff each time. The total mark shall be assessed in the Final Semester of the course in the 4th Clinical course as stipulated under the Rules in Schedule II.

#### **Ragging:**

Ragging is strictly condemned and prohibited in this college. The aggrieved students are requested to report the same to the Principal immediately to take speedy action. The guilty shall be dealt with harshly and severe action as demanded by the situation shall be taken against them as per the provisions of 'Maharashtra Prohibition of Ragging Act, 1999' and the directions issued by the Courts. The college has a duly constituted Anti-ragging Committee to deal with matters related to incidents of ragging.

#### **Women's Development Cell:**

The college has a College Women's Development Cell duly constituted as per the Vice-Chancellor's Directions bearing No. WDC/VCD/240 of 2008 issued by the Hon. Vice-Chancellor of the University of Mumbai.
